President, Glendale Teachers Association

Taline Krikorian Arsenian is a grandaughter of Armenian genocide survivors, a daughter of immigrants, a mother to two daughters, a math teacher, and the proud president of the Glendale Teachers Association. Motivated by a deep sense of responsibility to honor the memory of her grandmother and to ensure the atrocities of the past are never forgotten. Taline has worked tirelessly to promote Armenian genocide awareness, recognition, and curriculum to educators, students, and school communities. Through building relationships in her union and school district.

she has helped to support teaching and learning about genocide and the ongoing impacts of genocide denial. Taline believes that when students learn about atrocities and injustices, particularly those that directly impact the ancestors of their classmates, it can inspire a deeper sense of empathy and compassion while building responsibility to work towards a better world. Understanding the consequences of hatred, prejudice, and violence empowers students to stand up against injustice, promote peace, and advocate for the rights of others, ultimately fostering a more just and equitable society.

With thirteen years of classroom experience as an English and Special Education teacher, Ambereen has served as a Senior Policy/Program Specialist in the Teacher Quality department at the National Education Association for the past eight years, supporting state affiliates with creating and implementing professional learning systems and supports. Ambereen Khan-Baker is a renewed National Board Certified Teacher and currently a doctoral student at American University's Education Policy and Leadership program. Drew is the Co-Founder and Executive Director of the Academy for Human Rights, academyforhumanrights.org, a Buffalo, NY-based nonprofit designed to train the next generation of socially concerned citizens and teachers. A social studies teacher. Beiter also co-founded the Educators' Institute for Human Rights, eihr.org, a Washington, D.C.-based organization designed to provide human rights professional development training to teachers in Rwanda, Cambodia, and Bosnia-Herzegovina. He was the co-founder of both the I Am Syria Program, iamsyria.org, which was

the most trafficked source for educational materials on the refugee crisis, as well as Teaching About North Korea, teachingaboutnorthkorea.org. In the past 15 years, he has spoken in front of thousands of educators both nationally and globally on the power of education to heal the world. In January 2019, he was the American representative at a conference for educators in Poland commemorating the 75th Anniversary of the liberation of Auschwitz. In June 2022, he was inducted into the National Teachers Hall of Fame in Emporia, Kansas.

An 8th grade social studies teacher at Springville Middle School, Drew graduated with a M.A. in Education from SUNY Fredonia and a B.A. in Political Philosophy from Michigan State University. He is a proud member of the Springville Faculty Association, an affiliate of the New York State United Teachers (NYSUT).





**Procedures for Endorsement of Candidates**
