## Adoption of Preliminary Credentials Report

Steve Gorrie, NEA-Retired Elections Chair, gave the Preliminary Credentials Report: 328 Delegates registered for the Retired Annual Meeting; 313 delegates were present. A quorum was reached.

Steve Gorrie moved, on behalf of the NEA-Retired Elections Committee, the adoption of the Preliminary Credentials reports. Motion was adopted

# Adoption of the Standing Rules

Ross Dill, NEA-Retired Executive Council, moved, on behalf of the NEA-Retired Executive Council, the adoption of the 2024 Standing Rules as amended. Motion was adopted

#### Adoption of Agenda

Anita Gibson, NEA-Retired President, moved, on behalf of the NEA-Retired Executive Council, the adoption of the 2024 Retired Annual Meeting agenda with flexibility. Motion was adopted

#### Adoption of the 2023 Retired Annual Meeting Minutes

Marilyn Warner, NEA-Retired Secretary, moved, on behalf of the NEA-Retired Executive Council, the adoption of the minutes of the 2023 Retired Annual Meeting as posted on the NEA-Retired website. Motion was adopted

#### Adoption of the Guidelines for the Submission and Adoption of New Business Items

Ross Dill, NEA-Retired Executive Council, presented changes in the 2024 Guidelines for the Submission and Adoption of New Business Items:

Section II, A, has been changed to specify differences in the deadlines between online and live submissions.

Section III, E, allowance has been made for a delegate other than the original maker of the motion to move the item if the maker is not present for some reason, like illness, unexpected emergency, or God forbid, death.

Section III, H, the process has been expanded to require that all amendments must be in writing on a new form that will require delegates to press hard so that all copies are clear.

Section III, I, has been changed to show where, and in what order, forms will be distributed.

Section III, J, has been changed to accommodate the possibility that not all New Business Items will get dealt with during a meeting. In that case, any remaining New Business Items will be referred to the Executive Council.

Ross Dill, NEA-Retired Executive Council, moved, on behalf of the NEA-Retired Executive Council, the adoption of the proposed 2024 Guidelines for the Submission and Adoption of New Business Items. Motion was adopted

#### Adoption of the Bylaws Amendment

Ross Dill, NEA-Retired Executive Council, moved, on behalf of the Retired Executive Council, the adoption of the Bylaws Amendments Procedures as posted on the NEA- Retired Website. Motion was adopted

# Strategic Plan

Anita Gibson, NEA-Retired President, explained the NEA-Retired Strategic Plan. The Strategic Plan will be emailed to delegates following the Retired Annual Meeting.

#### Governance Committee

Ross Dill, NEA-Retired Executive Council, moved, on behalf of the NEA-Retired Executive Council, Bylaw Amendment #1 – Bylaw changes to the NEA-Retired Bylaws which are editorial changes.

Article VII, Section 2: Change "the" to "a" Article VII, Section 2: "than two full terms (as defined in Article VII, Section 2) in [the] any specific position [to which they are elected]." Article VIII, Section 3: "The NEA-Retired Executive Council shall provide leadership in carrying out the objectives of [the organization] NEA-Retired and shall support [the] NEA in the operation of the NEA-Retired program." Article IX, Section 4: 'Directors shall be elected at the NEA-Retired Annual in a manner consistent with [the] NEA requirements for three-year staggered terms." Article IX, Section 5: "The NEA-Retired Executive Council shall recommend an individual to fill [a Director's vacancy] the vacancy of an NEA Director." Article X, Section 4. Identical to Bylaws Amendment Number 4. It adds the words "in a manner" Article X, Section 5: changes "a Retired Alternate Director's vacancy" to "the vacancy of a Retired Alternate Director."

Article XII, Section 4: "Retired Alternate Directors shall be elected at the NEA-Retired Annual meeting in a manner consistent with [the] NEA Requirements for three-year staggered terms."

Ross Dill, NEA-Retired Executive Council, moved, on behalf of the NEA-Retired Executive Council, Bylaw Amendment #2 – the adoption of the addition of Bylaw Amendment Article VIII- NEA-Retired President-Elect.

#### Section 1. President-Elect

A. President-Elect is a non-voting position on the NEA-Retired Executive Council. When the winning candidate in the NEA-Retired presidential election is not the current president, that person shall become the President-Elect until they assume office on September 1. Once the President-Elect takes office as President, this position will remain vacant until the next change in leadership. B. Duties. Between the time the President-Elect is elected and when they assume the Presidency, they will have the opportunity to plan their term of office, beginning with developing and preparing an agenda for NEA-Retired for the upcoming membership year. The President-Elect will develop working relationships with the NEA-Retired Executive Council and the NEA-Retired Members of the NEA Board of Directors by explaining the agenda for NEA-Retired. The President-Elect will work with the Executive Council on beginning to build potential committee assignments. The President-Elect will develop working relationships with NEA-Retired state presidents and start to define the expectations of the state presidents, including gathering names for potential committee appointments. The President-Elect will develop working relationships with NEA leadership and staff. During this time period, the President-Elect may attend all virtual meetings as a guest of the outgoing President and will perform other duties as assigned by the President.

Lynnette Henley (CA) moved, seconded by Keith Swets (MI), to refer Bylaw Amendment #2 to committee. Motion failed

In discussion of the original motion, Keith Swets (MI) moved, seconded by Lynette Henley (CA), to close debate. Motion was adopted

#### **Report of Action Taken on 2023 New Business Items**

Ross Dill reported on the action taken on the 2023 New Business Items.

New Business Item #1: Asked that the NEA-Retired Annual Meeting support requiring that the registration date for future NEA-Retired Annual meetings be 45 days prior to the date of the NEA-Retired annual Meeting. This New Business Item was withdrawn by the maker.

New Business Item #2: Asked that the NEA-Retired Executive Council request that the appropriate NEA staff revamp the NEA-Retired website to provide for the following concerns:

1. Easy access from NEA.org to the NEA-Retired website

2. Twice monthly updates to the website

3. A method of making the website more user friendly for technologically challenged members

4. Readily accessible and downloadable forms

The motion was voted on and passed. The Executive Council has had several meetings with the NEA staff members responsible for maintaining the website, and the website has been improved to meet the criteria specified in the NBI as well as additional concerns expressed by the Council.

New Business Item #3: Asked that NEA-Retired provide designated seating for each delegation at the NEA-Retired Annual Meeting and that criteria should be used to ensure that state delegations are fairly distributed within the meeting spaces. The original motion and the attempted amendments were referred to the Executive Council. The Council created a seating chart that has resulted in the assigned seating for this year's Annual Meeting.

New Business Item #4: Proposed that, as an edues mitigation strategy, as a part of routine communication, NEA-Retired Leadership shall consider developing a program to assign one or more retired members to each school to communicate with each active member, in-person or by any appropriate means, to offer support. The motion was voted on and passed.

NEA-Retired Leadership was unable to complete the requested action in this NBI within this year's timeline. NEA-Retired Leadership continues to collect information on how to best handle this issue as needed on a state-by-state basis, with full implementation of a specific pilot program in the fall of 2024. Delegates should also know that steps are being taken in our strategic plan to accomplish this work by increasing training opportunities at the Retired Conference, surveying Retired state presidents to determine issues that Retired members care about so that we can hold informational webinars, and partnering with NEA to more fully involve Retired members in the campaign to promote, protect and strengthen public education. In addition, during 2024-25, the NEA-Retired President, in collaboration with state retired presidents, will work with active state presidents in states where legislation has created the need for a change to eDues to ensure that school leaders are supported by school leaders.

NBI 58: The NEA shall join in collaboration with other national unions whose members are affected by the Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO) to hold a national campaign to pass S 597 and HR 82, federal laws which repeal these measures. The campaign will not exceed \$1.5 million. The campaign will highlight the stories of impacted members, the negative effect on the economy and the repercussions of WEP/GPO on workforce recruitment and retention. The campaign may include publications such as media ads, television commercials, and major print sources.

Lynette Henley moved, seconded by Ross Dill, to close debate. Motion was adopted New Business Item 2024-1 was adopted.
